Ensure you have enough kit materials to perform the sample collection and prepare the room to be used.

The sample collector and donor must complete all highlighted fields in yellow on the collection & consent form.


Note the number of hair samples required - this must correspond to the number of

hair foils collected.

Pay particular attention to determine if a 'B' hair sample has been requested.



4. Prior to sample collection, refer to the hair envelope instructions and copy the required test details.



PRIOR TO SAMPLE COLLECTION

Refer to the Hair Envelope Instructions and copy the necessary test details (in red) on to the hair sample envelope.




Complete Sample Envelope - highlighted yellow areas 6. below. Donor must sign consent when collection complete.

- Donor's Name, DOB and Gender
- Record type of photographic ID and related number
- Specify if the hair to be collected is head or body hair
- Record the colour of the hair collected
- Hair treatment recorded with date
- Collection date recorded
- **Collectors Name printed/signed**
- All declared medication recorded for the PERIOD OF ANALYSIS including dose/strength/duration
- Donor's signature of consent obtained

Prepare for sample collection.


Take the sample kit and put on the gloves. Prepare the silver foils for securing samples by folding lengthways and forming a crease.





8. Prepare the area of the head where the sample is to be taken. When possible, leave a section of hair above the cut that will cover the area.

Take head hair from the crown of the head.



For long hair, use a hair clip if necessary



Note the length of hair required and use the ruler to measure available hair. If there may not be enough hair length at the crown of the head then call Crystal Health for further instructions

Cut as close to the scalp as possible to obtain the hair sample and place in the foil.










Place cut hair sample over coloured dot with the cut end (root end) protruding out of silver the foil if hair length allows.




Holding the hair sample firmly with one finger, fold over the silver foil to secure the sample in place.

If a 'B' sample collection is required, this will be indicated on page 1 of the sample collection and consent form.



Fold the foil again to ensure the sample is securely held prior to being transported to the laboratory.



One exception to the cut end protruding out of the foil is when collecting short lengths e.g. 1cm in length. However, you must ensure that the cut end is ALWAYS aligned to the coloured dot as shown.

> DO NOT CUT THE HAIR TO SIZE, THIS WILL BE DONE IN THE LABORATORY.

EACH SAMPLE SHOULD BE EQUAL TO THE THICKNESS OF A STANDARD **MOBILE TELEPHONE CHARGER CABLE - APPROX. 2-3mm**

It is important that you cut as close to the scalp as possible, with the curve of the scissors pressed into the

10. **Body hair collection ONLY (use razor or scissors)**

collection disc so that only a minimal amount of hair remains after collection. See Image C

hair sample as it will not have been cut to the root - See image B.

IMPORTANT - DO NOT MIX HEAD AND BODY HAIR


- Use scissors, electric razor or disposable razor to shave the body hair sample from the specified location.
- ✓ It is not necessary to identify the root end. However, cut the sample as close to the skin as possible to obtain the entire length of the hair.
- ✓ Fill the foil as shown.

- 1. Follow the hair collection
 - procedure as detailed in points 9 and 10 of this procedure. 2. Place the collected B hair sample in the 'B' sample envelope and
 - seal. 3. Instruct the donor to complete the details on the front of the envelope.
 - 4. Place the 'B' sample envelope into the standard Sample Envelope.



- 12. Place samples inside the Sample Envelope and ensure all sections have been completed.

Ensure the following tasks are completed before concluding 13. the sample collection.



IMPORTANT!

DECLARATION re that this sample is my own and the juckage was sealed in my ce. I understand the mason for this test and that the results reported to the person/organization requesting the test.

The donor MUST read the declaration and sign his/her consent for the test.

Place the security seal over the flap of the Sample Envelope where indicated. The **DONOR** must date and initial the seal.



Before applying the security tape, ensure all sections have been completed on **BOTH SIDES** of the Sample Envelope.

If applicable, complete Section 5 of Collection & Consent form - NON CONFORMITY

15. Post the samples and documentation to Crystal Health on the same day, using Royal Mail Special Delivery. For any test related queries, direct the donor to Crystal Health.

- ✓ Place the samples and all documentation in the C4 Manilla envelope provided.
